

CONSENT AND NOTICE REGARDING ELECTRONIC COMMUNICATIONS

- 1. Electronic Signature Agreement.** By selecting the “I Accept” button, you are signing this Agreement electronically. You agree your electronic signature is the legal equivalent of your manual signature on this Agreement. By selecting “I Accept” you consent to be legally bound by this Agreement's terms and conditions. You further agree that your use of a key pad, mouse or other device to select an item, button, icon or similar act/action, or to otherwise provide Aegis Financial instructions via the Aegis Financial web site or online account portal, or in accessing or making any transaction regarding any agreement, acknowledgement, consent terms, disclosures or conditions constitutes your signature (hereafter referred to as “E-Signature”), acceptance and agreement as if actually signed by you in writing. You also agree that no certification authority or other third party verification is necessary to validate your E-Signature and that the lack of such certification or third party verification will not in any way affect the enforceability of your E-Signature or any resulting contract between you and Aegis Financial. You also represent that you are authorized to enter into this Agreement for all persons who own or are authorized to access any of your accounts and that such persons will be bound by the terms of this Agreement. You further agree that each use of your E-Signature constitutes your agreement to be bound by the terms and conditions of the various Aegis Financial Disclosures and Agreements as they exist on the date of your E-Signature.
- 2. Consent to Electronic Delivery.** You specifically agree to receive and/or obtain any and all Aegis Financial related “Electronic Communications” (defined below) via your Aegis Financial account or email address that you have provided and maintain in your Aegis Financial account profile. The term “Electronic Communications” includes, but is not limited to, any and all current and future notices and/or disclosures that various federal and/or state laws or regulations require that we provide to you, as well as such other documents, statements, data, records and any other communications regarding your relationship with Aegis Financial. You acknowledge that, for your records, you are able to use the Aegis Financial online account management tools to retain Electronic Communications by printing and/or downloading and saving this Agreement and any other agreements and Electronic Communications, documents, or records that you agree to using your E-Signature. You accept Electronic Communications provided via Aegis Financial’s online account web site or portal as reasonable and proper notice for the purpose of any and all laws, rules, and regulations, and agree that such electronic form fully satisfies any requirement that such communications be provided to you in writing or in a form that you may keep.
- 3. Paper Version of Electronic Communications.** You may request a paper version of an Electronic Communication. You acknowledge that Aegis Financial reserves the right to charge you a reasonable fee for the production and mailing of paper versions of Electronic Communications. - 4. Revocation of Electronic Delivery.** You have the right to withdraw your consent to

receive/obtain communications via the Aegis Financial online account management site at any time. You acknowledge that Aegis Financial reserves the right to restrict or terminate your access to the Aegis Financial online account site if you withdraw your consent to receive Electronic Communications. 5. Valid and Current Email Address, Notification and Updates. Your current valid email address is required in order for you to obtain Aegis Financial online services. You agree to keep Aegis Financial informed of any changes in your email address. You may modify your email address by submitting a written request to Aegis Financial or by submitting a secure message thru your Aegis Financial online account portal. Aegis Financial may notify you through email when an Electronic Communication or updated agreement pertaining to your Aegis Financial account is available. Aegis Financial may also use your Aegis Financial online account for Electronic Communications. It is your responsibility to use your Aegis Financial online account regularly to check for Electronic Communications and to check for updates to this Agreement.

6. Hardware, Software and Operating System. You are responsible for installation, maintenance, and operation of your computer, browser and software. Aegis Financial is not responsible for errors or failures from any malfunction of your computer, browser or software. Aegis Financial is also not responsible for computer viruses or related problems associated with use of an online system.

7. Controlling Agreement. This Agreement supplements and modifies other agreements that you may have with Aegis Financial. To the extent that this Agreement and another agreement contain conflicting provisions, the provisions in this agreement will control (with the exception of provisions in another agreement for an electronic service which provisions specify the necessary hardware, software and operating system, in which such other provision controls). All other obligations of the parties remain subject to the terms and conditions of any other agreement.
